



# Ms. Honey Glendinning

I have owned dogs all my life. My parents always had purebred dogs. When they were first married my mom gave my dad an Irish Setter. I never knew that dog as he passed before I was born. The first dog I remember is actually a Dalmatian , Patches. She was fun and lived a good long life. After she was gone our family doctor recommended we get a Dachshund. Tiger was a standard smooth Black and Tan. He lived till just before we moved to BC in 1966. For the first time we did not have any pets. So, for my 16th birthday in 68 I asked for a dog. My parents knew I loved and wanted an Irish Setter and they surprised me with one.

When we went to pick him up the breeder said, Why don't you show him? I asked, To Who? She then explained dog shows. One was going to be in Vancouver in the next few weeks so we all went. I had no idea what was going on but I knew I had to be part of it. Thus started my love affair with this sport. I soon after bought myself a second one. My young sister said she wanted her own dog and my father sent me on a mission to find a good breeder of English Setters. Thus started my journey into English and stayed there for over 50 years under the kennel name Fantail. They have done incredibly well of which I am very proud. I started judging in 1983 and have judged throughout Canada and in Australia, Brazil, China, Colombia, England, Hong Kong, Indonesia, Japan, Korea, Malaysia, Mexico, New Zealand, Philippines, Thailand, USA.

I've recently moved to Lethbridge, Alberta, and am enjoying setting up a new home and all that involves as well as enjoying gardening and music.



# Ms. Yvonne Savard

My start into the dog world was walking into the show ring as a Junior Handler with a big male Bouvier des Flandres at the 7-day benched Sportsman Show in Toronto Ontario in 1969. The love for Bouviers and dog shows remained with her from that day forward. Breeding Bouviers under the prefix "BARBU Perm Reg'd", JBB and BARJEN, she has had the excitement of winning BOW at the American National Bouvier Specialty 5 times and being the owner of the Top Dog all Breeds in Canada in 1984. Yvonne has bred and shown multiple Best in Show winners both in Canada and the US. Although her main focus was Bouviers she has owned and shown Irish Setters, Doberman Pinchers, German Shepherds, Pekingese and presently an

Affenpinscher. Yvonne handled and trained various breeds in her career with dogs. Yvonne's professional life has always involved animals in some way from Veterinary Medicine to Animal Welfare. Yvonne served on the ABdFC- Health Committee, is an approved Breed Mentor and is a 25+ year member ABdFC as well as Past President of the Canadian BdFC. She is one of the founding members of the Bouvier des Flandres Club of BC. Currently she is a Territory Manager for a Veterinary Pharmaceutical Company. She has been judging since 1998 is an approved All Breeds Judge. She has had the great honor of judging both the American National Bouvier Specialty, the Canadian National Bouvier Specialty and the New Zealand Bouvier Specialty. She has had the pleasure of adjudicating in Canada, USA, Ireland, New Zealand, Australia and the Philippines.



# Mr. Torbjorn Skaar

I started in 1961 with horse riding both jumping and dressage. My first dog was a Great Dane from kennel Airways in 1968 and we later imported from USA. In 1980 when I met Paul Stanton, I was introduced to his breeds Lhasa Apso and Tibetan Terriers. In 1992 our kennel Tintavon was awarded the Hamilton Plaque for outstanding breeding of Lhasa Apso. We have bred with great success Lhasa Apso, Tibetan Terriers, Whippet and Thai Bangkaew Dog. I got my official license in 1992 and became FCI all breeds judge in 2015. I have judged on all five continents. I love my judging and my favourite groups are Sighthounds and the Toy group. I have been Chairman of the Tibetan breed club since 2001. I enjoy judging junior handling and I was committee member in SKK Junior handling committee for many years. My other interests include food, travelling and culture in general. Looking forward to visiting Vancouver Island again.



# Mr. Paul Stanton

I acquired my first dog in 1964, a Shetland Sheepdog named Tint and as I lived near the river Avon I took the affix Tintavon. In 1966 I went to work for the famous Hardacre Kennels of Anne Matthews then breeding mainly Basset Hounds but Anne had just started with Lhasa Apsos and Tibetan Terriers where I fell in love with the Apsos temperament and in 1969 I acquired my first Apso and I have owned or bred 5 UK Ch.s plus 15 all breed BIS winners. My first Tibetan Terrier became the immortal UK Ch Dokham Cavarodossi of Tintavon who was the first TT in the world to win all breeds BIS, which he did twice in 1974 at the

Birmingham shows, his double granddaughter Tintavon Desdemona (1 cc & 2 res CC.s) won Top Dog All Breeds in Sweden and Finland 1979. I am the only person to have owned/bred Ch.s I the 3 Tibetan breeds in the Utility Group.

I moved to Sweden in 1977 where I continued to breed Apsos and TT.s with great success. We (Torbjorn Skaar) kept brown Miniature Poodles for a short time making up 2 Int Ch.s and in our only litter we bred 2 Champions.

Whippets came into our lives in 1986 and we had good success with our few litters, keeping 1 female in each litter until our last litter where there were only 3 males which we kept one who was a group winner and he became our last whippet. With both of us judging internationally we cut back the breeding and showing our dogs.

In 2012 we introduced the Thai Bangkaew Dog to Europe (FCI group 5 Primitive Breed). Our dogs were the first in Europe to win a group and in the breeds first litter we bred World Winner and European Winners but sadly these dogs had or were carriers of PRA, so our breeding came to a halt although we have 2 eleven year olds at home.

I became an All Breeds Judge in 1996. I have now judged in over 60 countries on all continents. Some of my judging highlights are judging Lhasa Apsos at Crufts in 1981, Tibetan Terrier Silver Jubilee (UK), South Eastern Tibetan Spaniel Ch show (UK), The Chow Chow club Ch. Show and Chow of the year 2023 females (UK), Canadian English Springer Spaniel National specialty, 5 groups at AKC shows. Sydney, Perth and Hobart Royals, Judged BIS through out Europe, Asia and South America, Canada with a highlight judging BIS the Santa Barbara show 2022.

My other interests are gardening, opera and ballet and foreign culture.

# **HOW TO: APPLY FOR A TCN ONLINE**

A TCN (Temporary Competition Number) allows a dog that is eligible for CKC registration and/or an Event Registration Number (ERN) to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN).

Visit www.ckc.ca and click the red LOGIN button at the top right hand side of CKC's homepage.



2. On the login page, login to your Portal account.



- Individuals who haven't used the online portal yet will be required to create a portal account before they can submit a TCN application. If you have not yet created a Portal account, see Creating a CKC Portal Account.
- 3. Once logged in, you will arrive at your Dashboard.

4. On the right hand side of your Homepage, select "Dog Register", under the Quick Links section. This will take you to the online Dog Registration Application.



Select the appropriate answer to the first question, "Where was the dog born?".



- If you selected "Outside of Canada", select the appropriate country from the dropdown menu.
- Under "Competing in Events Only", select "Temporary Competition Number (TCN) - ..." from the registration type options.

Select the Official CKC Registration Type Registration of a Canadian Born dog that is a CKC recognized breed (can also compete in events) Competing in Events Only Canine Companion Number (CCN) - Allows mixed breed and purebred dogs of breeds not recognized by CKC to participate in some CKC performance events. Miscellaneous Certificate Number (MCN) — Allows listed breeds and purebred breeds not fully recognized or registered with CKC to enter an event and obtain titles. An MCN must be obtained prior to entering an event. Performance Event Number (PEN) - Allows an unregistrable dog of a CKC- recognized or listed breed to participate in most performance events. Temporary Competition Number (TCN) - Allows a dog that is eligible for CKC registration and/or an Event Registration Number (ERN) to participate in CKC events on a temporary basis. Dogs must be fully registered in order to receive titles.

- A TCN cannot be used for Listed Breeds (MCN) or dogs that will require a PEN (Performance Event Number) or CCN (Canine Companion Number).

# **CONFORMATION CLASSES**

The following Regular CKC Classes (divided by sex) will be offered:

JUNIOR PUPPY CLASS - This class shall be for any dog 6 months of age and under 9 months of age on the day of the show

SENIOR PUPPY CLASS - This class shall be for any dog 9 months of age and under 12 months of age on the day of the show

12 to 18 MONTHS – This class shall be for any dog 12 months of age and under 18 months of age on the day of the show.

CANADIAN BRED CLASS - This class shall be for any dog born in Canada. Champions of any country are excluded.

BRED BY EXHIBITOR CLASS - This class shall be for any dog owned and handled in the ring by owner/breeder. The handler MUST be the owner/co- owner AND breeder/co-breeder of the dog. The owner/breeder must handle the dog at the class level, but need not handle the dog for further awards

OPEN CLASS - This class shall be for all dogs.

SPECIALS ONLY CLASS - This class shall be for any dog that has a recorded CKC Registration or Event Registration Number and has attained the required points for Championship status. Note: A Listed dog may be moved to the Specials Only Class after the closing of entries, provided the CKC Individual or Event Registration Number was received prior to the first day of the show. The request to move a class dog to the Specials Only Class MUST be received by the Show Secretary ONE HOUR PRIOR TO BREED JUDGING. TCN Fees WILL NOT be refunded

# **NON-REGULAR CLASSES**

EXHIBITION ONLY - All dogs entered in this class shall be listed in the catalogue with the same particulars as dogs entered in regular competition. Dogs entered in this class MAY NOT COMPETE in any Regular class but may enter and compete in Non-Regular classes and/or Parades ONLY

BABY PUPPY – This class is for all dogs 4 months of age and under 6 months of age on the day of the show.

VETERANS CLASS - This class is for dogs 7 years of age and over on the day of the show. Dogs entered in these classes may be spayed or neutered.

# **UNOFFICIAL CLASS**

BREEDER/OWNER/HANDLER - You must be entered in a Regular Class to be eligible and handle the dog at all levels to be eligible for BOH in Breed, BOH in Group and BOH in Show. There is no entry fee but you must enter online or check the entry form in the box provided for mailed in entries. No exceptions.

# SEXUALLY ALTERED CLASSES

Eligibility for the Altered classes shall be limited to dogs over six months of age, which have been sexually altered by veterinary procedure. Points MAY NOT be carried from the regular competition judging to the Altered class judging. This class will be judged upon the completion of Best of Breed.

Two classes ONLY will be offered:

Altered Male and Altered Female

Classes will be placed first through fourth in both sexes, the first place winner from each sex will be declared Winners and the second place winner from each sex will be awarded Reserve. The Altered Winners Male and Altered Winners Female will then compete for Best Altered in Breed.



# **GENERAL RULES GOVERNING THESE SHOWS**

It is the responsibility of the Exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the Conformation Rule book are available online at www.ckc.ca

- 1. The Club reserves the right to remove any person from the show. The Show Superintendent shall have full control of the above shows and trials, which will be governed by CKC rules.
- 2. Any dog excused by the Show Superintendent or the Show Veterinarian for any reason shall not, after being excused, compete in any class for any award for the balance of the show.
- 3. The show committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune, to either dogs, exhibitors or patrons.
- 4. A Judge or any person participating in any capacity at a Dog Show held under CKC Rules shall not be subjected to any indignity of any kind during the progress of the show and it shall be the duty and obligation of the Club holding the show to see that this rule is effectively carried out. The Show Superintendent shall promptly report to the CKC any infringement of the rules, and the Discipline Committee shall have the power to take such action as it deems fit on receipt of a report indicating that this rule has been violated.
- 5. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the show grounds.
- 6. DOGS MUST BE READY FOR JUDGING. The Club will not be responsible for and is not obligated to provide any service for notifying owners or agents of breed or class judging. No ring shall be held up waiting for exhibitors or handlers. Exhibitors & Handlers with more than one dog shall have substitute handlers available so the judging will not be delayed. All start times are PACIFIC TIME.
- 7. The owner of a dog entered in these shows is entirely responsible for any error in entering his/her dog, regardless of how or by whom the entry was made.
- 8. A dog once disqualified for any reason at a championship show held under these rules cannot again be shown at a show held under these rules until the dog has been examined by an official committee appointed by the CKC and the committee finds the dog is free from the condition which prompted the disqualification. Application for reinstatement must be accompanied by a fee of \$115 plus GST (for Canadian residents) (\$230 non-resident), which shall be forfeited to the CKC if the examining committee is satisfied that the dog should remain disqualified. All awards earned at a dog show in violation of this rule shall be canceled by the CKC and the owner of the dog is subject to disciplinary action.
- 9. Exhibitors and handlers will be responsible for their dogs and for their equipment left at the Show Grounds.
- 10. For the benefit of the health of animals and the pleasure of the exhibitors and spectators we insist upon keeping our grounds and buildings as clean as possible. Exhibitors are responsible for cleaning up after their dogs. Please exercise your dog BEFORE taking it to the Judging ring. Dogs are to be exercised in the designated areas only, not in the vicinity of the ring areas.
- 11. No entry fee will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, and Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club.
- 12. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of the Show Committee.

# **FIRE SAFETY RULES:**

Extension cords may not be laid across an aisle.

Power bars are not permitted.

Aisles must be kept open at all times to allow everyone easy and speedy exit in case of emergency.

All designated FIRE LANES must be kept clear at all times or vehicles will be towed at owner's expense.

# **ADDITIONAL CLUB RULES:**

Exhibitors will be responsible for cleaning up after their dogs. Violators will be asked to leave the show grounds.

Crates will be allowed at ringside during the judging of your specific breed only and must be removed immediately after. No Exceptions.

Dogs are not allowed in washrooms and must be on leash at all timed on the show grounds or within the show building with the exception of the obedience rings.

The welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is distinctly understood that you will exercise control and restraint over the children in your care on the days of these shows.

The Club is not responsible for lost or stolen property from exhibitors or venders/concessions. The Club will use due care and diligence for the welfare of dogs and exhibitors but will not be responsible for, or assume any liability in the event of accident or misfortune to either dogs, exhibitors, spectators or vendors.

Plastic sheeting must be under all exercise pens.

Dogs must be exercised in the designated areas. Dogs may not relieve themselves on or near the building. Failure to observe this rule may result in dismissal.

Any tape used in the building has to be easily removable and must be removed after the show is competed. Colored tape is not allowed. You must leave your setup in the same clean condition you found it in when you first arrived at the show.

No liquid waste is to be disposed of in garbage cans.

All RV units must have buckets underneath for their sink drains. Anyone found discharging water on the grounds will be removed by order of the Health Department and may be subject to a fine.

The club reserves the right of restricting exhibitors grooming space.

Any videographer or photographer, other than the official videographer/photographer, that is going to take picture for which they will be remunerated will require written permission from the Nanaimo Kennel Club Show Committee and/or the official show videographer/photographer.

#### CANADIAN KENNEL CLUB SCHEDULE OF CHAMPIONSHIP POINTS

SECTION 2. The schedule to be employed in the determination of the number of points to be allocated to a dog awarded WINNERS shall be as follows: (\*Includes the dog awarded Winners.)

Dogs Competing*	1	2	3 to 5	6 to 9	10 to 12	13 or more
Points Allocated*	0	1	2	3	4	5

To determine the number of championship points earned by a dog awarded Winners, total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best of Opposite Sex and then consult the schedule set forth above. A dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for championship points. Further section 15.1.12 {C} has been added and states the dog must: "have earned at least one 2 point win either at the breed level or group level."

The system provides for additional points if a dog awarded winners also places in the Group as listed here under.

A class Dog awarded Best In Show at an all-breed championship show will be credited with five points inclusive of any points earned at the breed or group level. In no case may a dog earn more than five (5) points at a single show. To earn a Canadian Championship, a dog must earn at least ten championship points under at least three different judges; and be individually registered with the Canadian Kennel Club, or have a CKC Event Registration Number (ERN) and have earned at least one 2-point win either at the breed or group level. In order to obtain a Grand Champion title, a dog must obtain a minimum of 20 points which must include a minimum of two wins of at least 2 points and at least two (2) points after 12 months of age. In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for Grand Champion points. (d) Only the highest points earned at a single show are carried forward.

- 15.2.4 Grand Champion Bronze (GChB) The title of Grand Champion Bronze may only be earned after the completion of the CKC conformation title Grand Champion is attained.
- (a) Points for this title are only accumulated after the completion of the Grand Championship, and do not include the points earned in attaining the Grand Championship.
- (b) To be awarded a Grand Champion Bronze title, a dog must attain a minimum of 50 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/Specialty level. Only the highest points earned at a single show are carried forward.
- (c) Points accumulated prior to July 1, 2021 may be used to attain the GChB title, however, a minimum of five (5) points must be earned after July 1, 2021.
- 15.2.5 Grand Champion Silver (GChS) The title of Grand Champion Silver may only be earned after the completion of the CKC conformation title Grand Champion Bronze is attained.
- (a) Points for this title are only accumulated after the completion of the Grand Champion Bronze is attained, and do not include the points earned in attaining the Grand Championship Bronze.
- (b) To be awarded a Grand Champion Silver title, a dog must attain a minimum of 100 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/ Specialty level. Only the highest points earned at a single show are carried forward.
- 15.2.6 Grand Champion Gold: (GChG) The title of Grand Champion Gold may only be earned after the completion of the CKC conformation title Grand Champion Silver is attained.
- (a) Points for this title are only accumulated after the completion of the Grand Champion Silver is attained, and do not include the points earned in attaining the Grand Championship Silver.
- (b) To be awarded a Grand Champion Gold title, a dog must attain a minimum of 200 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best in Show/ Specialty level. Only the highest points earned at a single show are carried forward.
- 15.3 Grand Champion Excellent (GChEx) (48-06-12)
- 15.3.1 The title of Grand Champion Excellent may be granted only after the completion of the CKC Grand Championship Silver Title. Exhibitors will be required to submit to Shows & Trials the Grand Champion Excellent Record Sheet documenting the additional requirements. The Grand Champion Excellent Record Sheet Form is located on the CKC website.
- 15.3.2 To earn the title a dog must have earned the following during their career as a Special:
- (a) one (1) Best in Show or a Best of Breed at a breed national specialty (where a minimum of 10 dogs have competed)
- (b) three (3) Group 1st, or three (3) breed specialty best of breed wins.
- (c) a CKC performance title from any CKC Event. Titles excluded are: CGN, Herding Novice Tested Certificate, all Instinct titles from all events, as well as all Sprinter titles and all Chase Ability Program titles.
- 15.3.3 Best in Show, Best of Breed at a National Specialty, 3 Group wins, or 3 Specialty Best of Breed wins, must be attained after the completion of a regular championship. The performance title may be attained at any time in the dog's career.
- 1. Exhibitors are required to complete the Grand Champion Excellent Record Sheet form located on the CKC website and forward to CKC upon completion of requirements above.
- 2. Grandfathering of the previous version of the Grand Champion Excellent title will be honoured up until July 1, 2022.

# **AGREEMENT**

I (we) acknowledge that I (we), all exhibitors, handlers and patrons, know and abide by the "CKC Dog Show Rules", and that I am (we are) familiar with their content. I (we) agree that the Club holding this show has the right to refuse this entry for cause, which the Club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the Show and of the opportunity to have the dog judged and to win prize money, ribbons or trophies, I (we) agree to hold the Nanaimo Kennel Club, their members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of a dog while in or upon the show premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of a dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the Club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this show, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.
