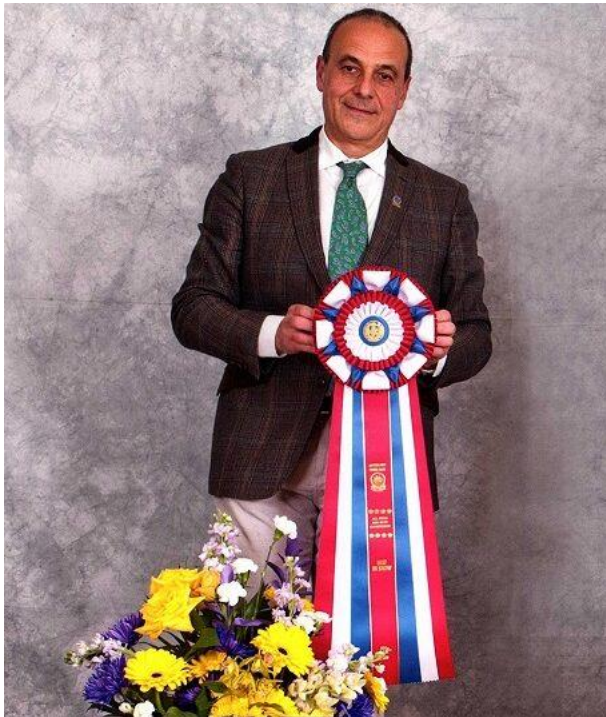

CONFORMATION JUDGE

Mr. Francesco Cochetti.....Roma, Italy



Born in a “dog family”. His father was a judge and bred together with his mother Poodles with the prefix “Della Perla Grigia”. His affix “Di San Gimignano” was recognized by the Italian Kennel Club (E.N.C.I.) in the year 1984. San Gimignano is a beautiful medieval town in Tuscany. At that time he bred Poodles, the lines came from England, from famous Tiopepi Kennel. He began to breed and show Chihuahuas year 1996 after marrying a Chihuahua breeder Tuula Lehtinen-Cochetti (Misty Meadow’s Chihuahuas). He breeds in small scale, together with his wife Toy Poodles too. They have bred more than 900 Champions, exported worldwide. He has also bred in the past Dobermann, Boston Terrier, Jack Russell Terrier and with his wife Papillon. They have won many Championship titles with their Chihuahuas and Poodles, including World and European Winners, English Champion and

many BIS around the world. He became a judge in year 1992 and in March 2013 he became an all rounder. He is listed in Italian Kennel Club (ENCI) as a specialist in the all toy breeds and most of the terriers. He is also a teacher of these breeds to new judges. At the moment he is the President of the Rome Kennel Club, President of the International Chihuahua Club, board member of the Italian Maltese and Bolognese Club, board member of ENCI Judges Committee. He also represents Italy to the FCI show judges commission. In the past, he has been board member of Club Cani Compagnia (Italian Toydogs Club) and the President of the Chihuahua Club (which was under Club Cani Compagnia).

He has judged all over the world, in more than 60 different countries, including Crufts, World and European Shows. He has judged BIS in the most prestigious shows around the world, including Melbourne Royal 2018 and many others and he had the honor to judge the group nine final at the European Show 2012 and at the World Shows 2018 and 2019. He has judged group three final at the European Show 2019. He has participated as a judge at the most important National specialties for Toy and Terrier breeds and Italian breeds.

He is the writer of a Chihuahua’s book, which has been translated in different languages. He has been often the lecturer for seminars organized also abroad, for Bolognese, Maltese, Chihuahua, Poodle, Jack Russell Terrier and Golden Retriever.

The tendering of NSF cheque shall be considered non-payment of entry fees and is punishable by returned cheque. Exhibitors whose charges are declined by the Bank Card Authorization Department will be assessed a service charge of \$25.00 for each transaction declined. Telephone entries are not accepted by the Show Secretary. Incomplete entries or entries received without fees, or entries received after the advertised closing date will not be accepted.

Attention foreign exhibitors, please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian Funds. If you sent a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please DO NOT make cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian Funds.

CONFORMATION CLASSES

The following Regular CKC Classes (divided by sex) will be offered:

JUNIOR PUPPY CLASS - This class shall be for any dog 6 months of age and under 9 months of age on the day of the show

SENIOR PUPPY CLASS - This class shall be for any dog 9 months of age and under 12 months of age on the day of the show

12 to 18 MONTHS – This class shall be for any dog 12 months of age and under 18 months of age on the day of the show

CANADIAN BRED CLASS - This class shall be for any dog born in Canada (Champions of any country excluded)

BRED BY EXHIBITOR CLASS - This class shall be for any dog owned and handled in the ring by owner/breeder. The handler **MUST** be the owner/co- owner **AND** breeder/co-breeder of the dog. The owner/breeder must handle the dog at the class level, but need not handle the dog for further awards

OPEN – This class shall be for all dogs

VETERANS CLASS - This class shall be for dogs 7 years of age and over on the day of the show. Dogs entered in these classes may be spayed or neutered.

SPECIALS ONLY CLASS - This class shall be for any dog that has a recorded CKC Registration or Event Registration Number and has attained the required points for Championship status. Note: A Listed dog may be moved to the Specials Only Class after the closing of entries, provided the CKC Individual or Event Registration Number was received prior to the first day of the show. The request to move a class dog to the Specials Only Class **MUST** be received by the Show Secretary **ONE HOUR PRIOR TO THE OPENING OF THE SHOW ON THE DAY CONCERNED**. Listing Fees **WILL NOT** be refunded.

NON-REGULAR CLASSES

EXHIBITION ONLY - All dogs entered in this class shall be listed in the catalogue with the same particulars as dogs entered in regular competition. Dogs entered in this class **MAY NOT COMPETE** in any Regular class but may enter and compete in Non-Regular classes and/or Parades **ONLY**

BABY PUPPY – This class is for dogs 4 months of age and under 6 months of age on the day of the show

BUILDING/GROUNDS HOUR

Bathing area will be available at the south end of the building. Slot money payment.

Juvenile Sweepstakes is to all puppies four months and under eighteen months of age regardless of place of birth. All dogs must be entered in one of the regular official classes on the same day. Dogs will be judged in one of the following four classes (divided by sex):

Baby Puppy - 4 months and under 6 months
Junior Puppy - 6 months and under 9 months
Senior Puppy - 9 months and under 12 months
Juvenile Puppy - 12 months and under 18 months

For final judging the first place puppy from each of the classes will be brought together for the final judging of Best in Sweepstakes.

Best in Sweepstakes - rosette & 15% of total fees collected for the Juvenile Sweepstakes
Best of Opposite in Sweepstakes - rosette & 10% of total fees collected for the Juvenile Sweepstakes
1st in each class - rosette & 6.25% of total fees collected for Juvenile Sweepstakes
2nd to 4th in each class - rosette
25% of fees collected will be retained by the club to defray costs

VETERAN SWEEPSTAKES - SATURDAY, APRIL 18th, 2026 at noon

Veteran Sweepstakes is open to all dogs 7 years of age and over and entered in a regular breed class or for exhibition only.

Spayed and neutered dogs may compete provided they are also entered in exhibition only.

Dogs to be judged in one of the following two classes (divided by sex):

7 years and under 9 years
9 years and over

For final judging the first place winner from each of the classes will be brought together for the final judging of Best in Sweepstakes and Best Opposite Sex in Sweepstakes

Best in Sweepstakes - rosette & 15% of total fees collected
Best Opposite Sex in Sweepstakes - rosette & 10% of total fees collected
1st in each class - rosette & 12.5% of total fees collected
Rosette for 2nd to 4th in each class
25% of fees collected will be retained by the club to defray costs

JUNIOR HANDLING - SATURDAY APRIL 18th, 2026 at noon

Judge: Amanda Weiss

Entries will be accepted at the show secretary's desk up to one hour prior to the event.

Entry Fee: free

The following classes will be provided:

Pee Wee (non-competitive) - 4 to 6 years
Junior Novice - 7 to 10 years
Junior Open - 7 to 10 years
Intermediate Novice - 11 to 14 years
Intermediate Open - 11 to 14 years
Senior Novice - 15 to 18 years
Senior Open - 15 to 18 years

Note: Pee Wees do not compete for best overall.

Competition is open to all Junior Handlers between the ages of 4 and up to 18 years of age (of the competition year). Dogs handled by the juniors must be entered in a Regular Conformation class or in Exhibition Only on Sunday. Dogs do not need to be owned by the junior.

Pee Wees - a participant rosette and prize

Best Overall Handler - rosette and prize

First in each class - rosette and prize

2nd to 4th in each class - ribbon and prize

Please note that effective January 1, 2016, in accordance with Section 3.4.1 of the Junior Handling Rules & Regulations, Junior Handlers will be required to apply to CKC Head Office for a **Junior Handling Number**. Section 3.4.1 "Junior Handler with the exception of Pee Wees, must apply to CKC Head Office on the appropriate form for a Junior Handling Number within 30 days of competing in their first Junior Handling event. This Junior Handling Number will be used by the Junior Handler for the duration of their Junior Handling career. If a Junior Handling number is not obtained, Junior Handling points earned will not be tracked."

GENERAL RULES GOVERNING THESE SHOWS:

It is the responsibility of the Exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the Conformation Rule book are available online at www.ckc.ca

1. The Club reserves the right to remove any person from the show. The Show Superintendent shall have full control of the above shows and trials, which will be governed by CKC rules.
2. Any dog excused by the Show Superintendent or the Show Veterinarian for any reason shall not, after being excused, compete in any class for any award for the balance of the show.
3. The show committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune, to either dogs, exhibitors or patrons.
4. A Judge or any person participating in any capacity at a Dog Show held under CKC Rules shall not be subjected to any indignity of any kind during the progress of the show and it shall be the duty and obligation of the Club holding the show to see that this rule is effectively carried out. The Show Superintendent shall promptly report to the CKC any infringement of the rules, and the Discipline Committee shall have the power to take such action as it deems fit on receipt of a report indicating that this rule has been violated.
5. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the show grounds.
6. **DOGS MUST BE READY FOR JUDGING.** The Club will not be responsible for and is not obligated to provide any service for notifying owners or agents of breed or class judging. No ring shall be held up waiting for exhibitors or handlers. Exhibitors & Handlers with more than one dog shall have substitute handlers available so the judging will not be delayed. All start times are Pacific Time.
7. The owner of a dog entered in these shows is entirely responsible for any error in entering his/her dog, regardless of how or by whom the entry was made.
8. A dog once disqualified for any reason at a championship show held under these rules cannot again be shown at a show held under these rules until the dog has been examined by an official committee appointed by the CKC and the committee finds the dog is free from the condition which prompted the disqualification. Application for reinstatement must be accompanied by a fee of \$115.00 plus GST which shall be forfeited to the CKC if the examining committee is satisfied that the dog should remain disqualified. All awards earned at a dog show in violation of this rule shall be cancelled by the CKC and the owner of the dog is subject to disciplinary action.
9. Exhibitors and handlers will be responsible for their dogs and for their equipment left at the Show Grounds.
10. For the benefit of the health of animals and the pleasure of the exhibitors and spectators we insist upon keeping our grounds and buildings as clean as possible. Exhibitors are responsible for cleaning up after their dogs. Please exercise your dog **BEFORE** taking it to the Judging ring. Dogs are to be exercised in the designated areas only, not in the vicinity of the ring areas.
11. No entry fee will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, and Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club.
12. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of the Show Committee.

FIRE SAFETY RULES:

Extension cords may not be laid across an aisle.

Power bars are not permitted.

Aisles must be kept open at all times to allow everyone easy and speedy exit in case of emergency.

All designated FIRE LANES must be kept clear at all times or vehicles will be towed at owner's expense.

ADDITIONAL CLUB RULES:

Exhibitors will be responsible for cleaning up after their dogs. Violators will be asked to leave the show grounds.

Crates will be allowed at ringside during the judging of your specific breed only and must be removed immediately after. No Exceptions.

Dogs are not allowed in washrooms and must be on leash at all times on the show grounds or within the show building with the exception of the obedience rings.

The welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is distinctly understood that you will exercise control and restraint over the children in your care on the days of these shows.

The Club is not responsible for lost or stolen property from exhibitors or vendors/concessions.

The Club will use due care and diligence for the welfare of dogs and exhibitors but will not be responsible for, or assume any liability in the event of accident or misfortune to either dogs, exhibitors, spectators or vendors.

Plastic sheeting must be under all exercise pens.

Dogs must be exercised in the grass areas to the West of Hall 1. Dogs may not relieve themselves on or near the building. Failure to observe this rule may result in dismissal. Any tape used in the building has to be easily removable and must be removed after the show is completed. Colored tape is not allowed. You must leave your setup in the same clean condition you found it in when you first arrived at the show.

No liquid waste is to be disposed of in garbage cans. Exhibitors must use the garbage bins provided outside the building.

All RV units must have buckets underneath for their sink drains. Anyone found discharging water on the grounds will be removed by order of the Health Department and may be subject to a fine.

No catering of any kind is permitted.

The club reserves the right of restricting exhibitors grooming space.

Grooming is not allowed in the Obedience benching area.

Any videographer or photographer, other than the official videographer/photographer, that is going to take pictures/videos, for which they will be paid, will require written permission from the Renaissance Dog Assoc. Show Committee and the official show videographer/photographer.

CANADIAN KENNEL CLUB SCHEDULE OF CHAMPIONSHIP POINTS

SECTION 2. The schedule to be employed in the determination of the number of points to be allocated to a dog awarded WINNERS shall be as follows: (*Includes the dog awarded Winners.)

Dogs Competing*	1	2	3 to 5	6 to 9	10 to 12	13 or more
Points Allocated*	0	1	2	3	4	5

To determine the number of championship points earned by a dog awarded Winners, total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best of Opposite Sex and then consult the schedule set forth above. A dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for championship points. Further section 15.1.12 {C} has been added and states the dog must: "have earned at least one 2 point win either at the breed level or group level."

The system provides for additional points if a dog awarded winners also places in the Group as listed here under.

A class Dog awarded Best In Show at an all-breed championship show will be credited with five points inclusive of any points earned at the breed or group level. In no case may a dog earn more than five (5) points at a single show. To earn a Canadian Championship, a dog must earn at least ten championship points under at least three different judges; and be individually registered with the Canadian Kennel Club, or have a CKC Event Registration Number (ERN) and have earned at least one 2-point win either at the breed or group level.

In order to obtain a Grand Champion title, a dog must obtain a minimum of 20 points which must include a minimum of two wins of at least 2 points and at least two (2) points after 12 months of age. In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for Grand Champion points. (d) Only the highest points earned at a single show are carried forward.

15.2.4 Grand Champion Bronze (GChB) The title of Grand Champion Bronze may only be earned after the completion of the CKC conformation title Grand Champion is attained.

(a) Points for this title are only accumulated after the completion of the Grand Championship, and do not include the points earned in attaining the Grand Championship.

(b) To be awarded a Grand Champion Bronze title, a dog must attain a minimum of 50 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/Specialty level. Only the highest points earned at a single show are carried forward.

(c) Points accumulated prior to July 1, 2021 may be used to attain the GChB title, however, a minimum of five (5) points must be earned after July 1, 2021.

15.2.5 Grand Champion Silver (GChS) The title of Grand Champion Silver may only be earned after the completion of the CKC conformation title Grand Champion Bronze is attained.

(a) Points for this title are only accumulated after the completion of the Grand Champion Bronze is attained, and do not include the points earned in attaining the Grand Championship Bronze.

(b) To be awarded a Grand Champion Silver title, a dog must attain a minimum of 100 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/ Specialty level. Only the highest points earned at a single show are carried forward.

15.2.6 Grand Champion Gold: (GChG) The title of Grand Champion Gold may only be earned after the completion of the CKC conformation title Grand Champion Silver is attained.

(a) Points for this title are only accumulated after the completion of the Grand Champion Silver is attained, and do not include the points earned in attaining the Grand Championship Silver.

(b) To be awarded a Grand Champion Gold title, a dog must attain a minimum of 200 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best in Show/ Specialty level. Only the highest points earned at a single show are carried forward.

15.3 Grand Champion Excellent (GChEx) (48-06-12)

15.3.1 The title of Grand Champion Excellent may be granted only after the completion of the CKC Grand Championship Silver Title. Exhibitors will be required to submit to Shows & Trials the Grand Champion Excellent Record Sheet documenting the additional requirements. The Grand Champion Excellent Record Sheet Form is located on the CKC website.

15.3.2 To earn the title a dog must have earned the following during their career as a Special:

(a) one (1) Best in Show or a Best of Breed at a breed national specialty (where a minimum of 10 dogs have competed)

(b) three (3) Group 1st, or three (3) breed specialty best of breed wins.

(c) a CKC performance title from any CKC Event. Titles excluded are: CGN, Herding Novice Tested Certificate, all Instinct titles from all events, as well as all Sprinter titles and all Chase Ability Program titles.

15.3.3 Best in Show, Best of Breed at a National Specialty, 3 Group wins, or 3 Specialty Best of Breed wins, must be attained after the completion of a regular championship. The performance title may be attained at any time in the dog's career.

1. Exhibitors are required to complete the Grand Champion Excellent Record Sheet form located on the CKC website and forward to CKC upon completion of requirements above.

2. Grandfathering of the previous version of the Grand Champion Excellent title will be honoured up until July 1, 2022

AGREEMENT

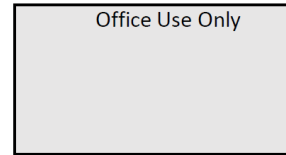

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this show, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.
