Dr. Guillermo Cavazos de las Fuentes

Guillermo Cavazos de las Fuentes is a veterinarian, international dog show judge, educator, and writer with more than three decades of experience in the purebred dog world. He grew up in a family deeply connected with animals and the breeding of Airedale Terriers and Labrador Retrievers. From an early age, he developed a strong appreciation for canine care, responsible breeding, and the unique bond between humans and dogs. In 1988, he joined his local kennel club in northern Mexico, where he was trained as a judge's ring steward. This experience introduced him to the sport of purebred dogs and marked the beginning of his participation in dog shows, initially presenting his own Labrador Retriever and Smooth Dachshund, and soon after handling dogs for other members of the club.

Committed to academic excellence and professional development, Cavazos pursued a degree in Veterinary Medicine and Animal Science at the Universidad Nacional Autonoma de Mexico (UNAM). His thesis, 'Care and Grooming of the Hair and Skin of the Dog', documented grooming techniques and dermatological considerations for 56 breeds. The work became the first canine grooming manual written in Spanish by a Mexican author and was later used as educational material in grooming courses he taught across Mexico and Central America.

During and after completing his studies, he remained closely involved with the Mexican Kennel Club (FCM), attending seminars and working as a professional handler. In December 1994 he achieved his first Best in Show (BIS) victory with a German Shorthaired Pointer female. During this period, he also completed his social service at the FCM's Hereditary Diseases Clinic, beginning a professional relationship with the institution that has remained strong over the years.

In 1995, Cavazos moved to the United States to work under the renowned professional handler and current judge Clay Coady, gaining valuable experience in structure evaluation, grooming, and presentation across multiple breeds while attending major dog shows throughout the country. He returned to Mexico City in 1996 to pursue a full-time career as a professional handler, successfully campaigning numerous breeds including Dachshunds, Beagles, Yorkshire Terriers, Borzois, Bloodhounds, Mastiffs and many more. In 1997 he was named Handler of the Year by the FCM, following a remarkable campaign in which an Mastiff he presented became Dog of the Year with 27 Best in Show victories.

Also in 1997, recognizing the potential of emerging digital platforms, Dr Cavazos co-founded Perros de Mexico, one of the first websites dedicated to promoting the purebred dog sport in Mexico. The platform provided articles, breeder directories, dog show calendars, and educational content, including a special section designed for children interested in the world of dogs. In 2003 he relocated to Guadalajara where he founded the veterinary clinic Pet Place and began breeding Beagles and Yorkies. He founded DogCommunity, an educational initiative focused on promoting the sport of purebred dogs and improving the handling skills of owners and exhibitors through structured handling classes held twice a week.

In 2010 Cavazos began his career as a conformation judge, an activity that has become one of his greatest professional passions. Today he is licensed as an All-Rounder, authorized to evaluate all breeds, and has officiated at dog shows internationally. Throughout his career he has handled and/or judged dogs in numerous countries, including Mexico, the United States, Canada, Dominican Republic, Brazil, Guatemala, El Salvador, Costa Rica, Colombia, Cuba, Puerto Rico, Portugal, Spain, Czech Republic, Switzerland, Finland, and England. In 2021 he launched 'Platicas Caninas' (Canine Talk), the first Spanish-language video podcast dedicated to the sport of purebred dogs. The project also includes a YouTube channel featuring more than 180 videos and extensive coverage of major international dog shows such as the World Dog Show Brno 2021, Crufts 2022, World Dog Show Madrid 2022, Crufts 2023, World Dog Show Geneva 2023, World Dog Show Zagreb 2024, World Dog Show Helsinki 2025 and World Dog Show Bologna 2006. The initiative is designed to educate enthusiasts and expand public awareness of the sport. Dr Cavazos has also maintained a lifelong interest in writing. At the age of twelve he won a state poetry competition organized by Mexico's Department of Public Education and contributed regularly to his school newspaper. In 2022 he was accepted as a member of the World Dog Press Association (WDPA), based in Belgium and in 2025 at Dog Writers Association of America, in recognition of his published work in international canine media. His articles have appeared in numerous publications including Canafilo and Perros Pura Sangre (official gazette of the FCM), Molosos Arena (Spain), and Show Beagles Worldwide (Czech Republic); Gaceta Canina (Colombia) as well as various digital platforms dedicated to the global dog community.



Mr. Fabian Daza

I was born in Barranquilla, Colombia, I am a urologist and have been involved in purebred dogs from an early age. I started French bulldog in 2003.

I was among the first French Bulldog breeders in the country, winning the championship title with the DAZSAN DU UPARI suffix. Since the beginning of breeding, I have made an effort to obtain high quality specimens that have competed in Colombia and other countries of the American continent. Additionally, at beginning I owe a Weimaraner. Lastly, I have been involved in Norwich Terrier, Bull Terrier and close to English Springer Spaniel and Belgian Shepherd Groenendael breeding.

I have been involved for many years in the education of doctors in my specialty in various undergraduate and postgraduate programs in the country, former president of the Colombian Society of Urology, I have made that commitment to canine fantasy. As a member of the Asociación Club Canino Colombiano (Colombian Kennel Club), I actively participated in all the educational events and in the training process of new judges that will be carried out under the direction of the Association. He has been a member of the Board and is currently president of the Bogotá Kennel Club, associated with the ACCC. I actively participated in meetings of the Canine Clubs of Latin America (FCI America and the Caribbean Section) and SICALAM, Delegate of Colombia to the FCI General Assembly in Paris and participated in various

conferences and courses for judges and breeders of purebred dogs.

Currently licensed as International FCI - Colombian Canine Club Association Judge for All Breeds. I have judged in Colombia, Mexico, Costa Rica, Guatemala, Canada (Ontario, British Columbia and New Brunswick), United States, El Salvador, Thailand (January 13, May 14), Philippines (CACIB Dog Show Manila Circuit 2012) , Argentina, Brazil, Peru, Chile, Latvia (Baltic Winner 2013), Estonia, Finland, Cyprus, Panama, Mexico, Guatemala, South Africa, China, Canada (several provinces), Costa Rica (Americas & Caribbean FCI Section Dog Show 2014 and 2021), Japan (Fukuoka CACIB 2015), India, Spain, Uruguay, Ecuador, Puerto Rico, Bolivia, New Zealand (2017), Australia (Melbourne Royal 2017 as BEIS Judge) and the WA FCI International Winter Show in Perth in 2022 , FCI Asia & Pacific Section Show in Malaysia, Singapore, Indonesia (The National Show), Taiwan, Greece, Honduras and also French Bulldogs, Terriers and other Specialty breeds in various countries. In 2022 I judged at World Dog Show in Sao Paulo, Brazil as well in the Centenary Dog Show CBKC.



Mr. Rade Dakic

Rade Dakic is now one of the oldest breeders of American Staffordshire Terriers in Europe, not by his age, but because he started with this breed in 1985. and registered his kennel "Franstal's" in FCI, in 1987.

He started his breeding program with old "Simba Camp" dogs, owned by Ruth Riols, from Germany, which went back to old Fraja, Har Wyn and Ruffians, and even today he has descendent of that old dog from 1985/1986.

Before Amstaffs, Rade Dakic was owner of German Hunting Terriers, Airedale Terriers, Bullterriers, West Highland White Terriers, Staffordshire Bull Terriers, Border Terriers, so we can consider him as a "terrier-fanatic".

But the most of his terrier love, he dedicated to the American Staffordshire Terriers.

His Franstal's kennel was the first officially registered Amstaff kennel in his country and the first litter of amstaffs registered in Kennel Club of Serbia was bred by Rade Dakic. From his kennel came cca 50 champions at 4 continents. He was also founder of the first special breed club in his country. He was secretary of that club for 4 years. Also, he was founder and first chief-editor of the club magazine called "Gladiator", and he was president of several Organization Committees and organized several very successful National Specialties for Amstaffs and other bull type terrier

breeds in his own country.

Rade Dakic was a first " Amstaff breeder - judge " in his country and probably in whole Europe, too. He got his judging license in 1992 and since then he judged at the most prestigious shows in Europe (including The World dog show and The European dog show), from far east of Russia to Portugal. He also judged in USA, Canada and Australia.

Today, he is a well-known International FCI judge for many breeds. He is authorized to judge FCI groups 1, 2,3,6,7,8,9 and American akita from FCI group 5.

Rade Dakic wrote the first book about Amstaffs in his country. That book had several editions. He also wrote several Annual (Champion's) Books about champions from former Yugoslavia, Serbia, about All World and European Champions. He was also co-author of several books. One of them was about the most famous blood lines in Amstaffs.

Beside books about Amstaffs, Rade Dakic wrote over 20 other books about different breeds. He is still writing for several dog magazines and web forums and is member of the WDPA (World Dog Press Association). He cooperated with several Radio and TV Stations in his country which dedicated part of their program to dog topics.

Rade Dakic also wrote 2 books of love and bohemian poetry, one book of short stories and produced a musical CD. He is also a amateur painter.



Ms. Aida Rivera Franco

Born in Bogotá, Colombia. Licenced in education and administration.

Is currently the Headmistress at Clermont Bilingual School in Bogotá.

Married to Mr. Juan Alberto Grillo Londoño, who also shares the hobby of breeding pure breed dogs. In 1990, along with her husband, founded the Santana Kennel, which has bred and exhibited around 85 national and international champions.

Their most representative breeds have been: Chinese Crested Dog, Pug, Shit-tzu, Standard Dachshund, Beagle, Pomeranian, Shiba-Inu, Color and White Bull Terrier, Yorkshire Terrier, Fila Brasileiro, Napolitan and Basset Hound with their Pomeranian "Grafenhorst Diamond Chip", they received the Best National Dog award in the Ranking on 2002, with 15 Best in Show and in 2011 with an adult Pom and with a junior Standard Dachshund.

She proudly owns the first adult and junior dogs in the Ranking 2011.

Co-founder of the "Sabana Kennel Club" in Bogotá on 1997, and worked as vice president, secretary and show director.

She currently works as show director and head of the public relations committee. Is an active member of the main Kennel Club in Colombia (Asociación Club Canino Colombiano)

Is the representative from Colombia at the FCI Show Commissions since 2007.

Also works in the Colombian Kennel Association as member of the public relations committee with the general organization of the Americas and Caribbean dog show in Bogotá, March 2016 and with the general workshops and education for new judges, handlers and children. Is one of the members of the disciplinary committee of the Colombian Kennel Club.

She has been invited to judge many all breed and groups specialties in Colombia and all general breed shows in Argentina, Uruguay, Ecuador, Brasil, Costa Rica, Bolivia, Perú, Chile, Guatemala, Nicaragua, Dominican Republic, El Salvador, Venezuela, United States of America, Sicalam 2016 in Lima-Perú, Mexico, Canada, Russia, Luxemburg, Lithuania, Latvia, Netherlands, Portugal, Norway, Sweden, Denmark, Ireland, Hungary, France, Italy, Spain, Croatia, San Marino, Bosnia, Philippines, India, China and Taiwan. She was judging in the World Dog Show in Amsterdam 2018 and the WDS in Geneve (Switzerland) in 2023. Also at the European Dog Show in Budapest 2021 and Herning (Denmark) in 2023.

Lately she is importing American and European multi champion dogs of breeds not very common in Colombia to introduce those in the shows.



Mr. Juan Grillo

Since 1990 he has been working at The Clermont School in Bogotá as a general manager, whilst working with his own transportation company and agriculture activities. When he was two months old his parents gave him a Boxer that lived with him until he was nine years old. Afterwards he got a Great Dane and Collie shepered. During the dog shows the results were very good, winning the first championships. On December 1990, he got married to Aida Rivera Franco, who also shares the hobby of dogs. They started the breeding of Fila Brasileiro, Napolitan Mastiff, winning during two years the top breed, with approximately ten championships. After that, they imported Sharpei and Dogo de Bourdeux, first dogs of these breeds in Colombia, generating interest and getting many championships. He has had the

opportunity of handling and breeding Beagle, Bull Terrier, Siberian Husky, Pug, Pomeranians and Shiba Inu. In 1997, they imported Chinese Cresteds, winning more than 20 international championships and the first Best in Show in Latin America for this breed. Currently they show and breed Dachshunds, Chinese Cresteds, Smooth Fox Terriers, Siberian Husky, Basset hound, Pugs and Pomeranians, wining with one Pom the best all around dog breed of the year awarded in Colombia in 2002 and 2011 with an adult Pom and with a junior Standard Dachshund. As handler and breeder he has always had the best breeds from the ones he chooses and has had more than 120 international championships, showing just his own dogs. Since 1997 he has been the president of the "Corporación Club Canino de Sabana", and treasurer and member of the board of the Asociacion Club Canino Colombiano since 2002. Currently he is the President of the judges committee in Colombia, as well as representative and member for the FCI judges commission since 2007. He has been invited to judge in Colombia, Perú, Brasil, Bolivia, Argentina, Uruguay, Chile, Ecuador, Venezuela, Cuba, Dominican Republic, Guatemala, Nicaragua, El Salvador, Honduras, Costa Rica, Panamá, México, United States, Canada, Russia, Norway, Luxemburg, France, Portugal, Cyprus, Germany, Lithuania, Latvia, Netherlands, Ireland, Sweden, Denmark, Philippines, Taiwan, India, Japan, China, Australia and Sicalam 2013 and 2015, Americas and Caribbean Section Show, World Dog Show in 2017.

I am a lifetime member of the CKC. I have bred over 100 CKC Champion English Springer Spaniels and French Bulldogs including many BIS, BPIS, and BBPIS. I have had many top winning dogs at the breed level in Canada and the United States. I have been showing since 1987 and judging since 2022.

4.1.5 No person may approach a judge wither directly or otherwise, orally, in writing or electronically, to favour his entry. Disciplinary action will be taken against any person who violates this rule, or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the action.

19.7 It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

Exhibitors, handlers, judges and assistants are expected to participate with honesty, fairness and integrity, ever mindful of the practice of "good sportsmanship", before, during and after the Vernon show. Any person engaging in an activity that might be considered malicious, threatening or constitutes bullying, including but not limited to social media, will be asked to leave the show without compensation and will be banned from any future Vernon shows.

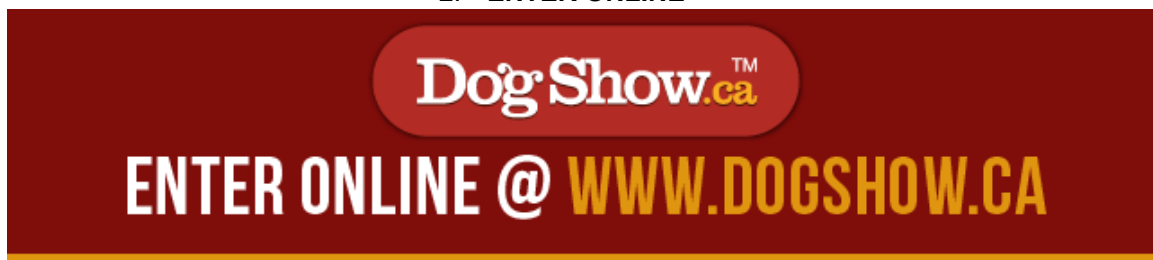

Exhibitors whose charges are declined by the Bank Card Authorization Department will be assessed a service charge of \$25.00 for each transaction declined. Telephone entries are not accepted by the Show Secretary. Incomplete entries or entries received without fees, or entries received after the advertised closing date will not be accepted.

Attention foreign exhibitors, please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian Funds. If you sent a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please DO NOT make cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian Funds. Your understanding and cooperation is appreciated. Thank you.

CONFORMATION CLASSES

The following Regular CKC Classes (divided by sex) will be offered:

JUNIOR PUPPY CLASS - This class shall be for any dog 6 months of age and under 9 months of age on the day of the show

SENIOR PUPPY CLASS - This class shall be for any dog 9 months of age and under 12 months of age on the day of the show

12 to 18 MONTH CLASS - This class shall be for any dog 12 months but under 18 months of age on the day of the show

CANADIAN BRED CLASS - This class shall be for any dog born in Canada.
(Champions of any country excluded)

BRED BY EXHIBITOR CLASS - This class shall be for any dog owned and handled in the ring by owner/breeder. The handler **MUST** be the owner/co- owner **AND** breeder/co-breeder of the dog. The owner/breeder must handle the dog at the class level, but need not handle the dog for further awards

OPEN CLASS - This class shall be for all dogs

SPECIALS ONLY CLASS - This class shall be for any dog that has a recorded CKC Registration or Event Registration Number and has attained the required points for Championship status. Note: A Listed dog may be moved to the Specials Only Class after the closing of entries, provided the CKC Individual or Event Registration Number was received prior to the first day of the show. The request to move a class dog to the Specials Only Class **MUST** be received by the Show Secretary **ONE HOUR PRIOR TO BREED JUDGING**. TCN Fees **WILL NOT** be refunded

EXHIBITION ONLY - All dogs entered in this class shall be listed in the catalogue with the same particulars as dogs entered in regular competition. Dogs entered in this class **MAY NOT COMPETE** in any Regular class but may enter and compete in Non-Regular classes and/or Parades **ONLY**

NON-REGULAR CLASSES

BABY PUPPY CLASS - This class shall be for any dog 4 months of age and under 6 months of age on the day of the show. The awards for this class are: Best Baby Male, Best Baby Female, Best Baby Puppy in Breed, Best Baby Puppy in Group, Best Baby Puppy in Show (This class will be held on completion of Best Puppy in Breed, Best Puppy in Group and **PRIOR** to Best in Show)

VETERANS CLASS - Dogs must be 7 years of age and over on the day of the show. Dogs entered in this class may be spayed or neutered. Awards for this class are: Best Male Veteran, Best Female Veteran, Best Veteran in Breed, Best Veteran in Group, Best Veteran in Show (This class will be held on completion of Best Puppy in Breed, Best Puppy in Group and **PRIOR** to Best in Show)

UNOFFICIAL CLASSES

Amateur Owner/Handler

Exhibitor Eligibility

1. Exhibitors must declare their dog Owner Handled Competition eligible at the time of entry using the check box on the entry form or the indication of class entrance on online entry.
2. The handler must be an owner of record listed in the catalogue.
3. **Professional handlers, household members and current assistants to professional handlers may not exhibit.** Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay or received payment for handling a dog.
4. Dogs must be handled by an owner-handler throughout the breed level competition for the regular show. This includes the class competition and subsequent competition in the breed ring. The same is true for all levels of group and show competition.
5. The Best Owner Handled in Breed will be selected from the eligible dogs that competed in the Best of Breed competition for the regular show. This includes Winners Dog, Winners Bitch. This excludes all dogs defeated during class and winners competition for the regular show.

Determining Best Owner Handled in Breed

The selection of the Best Owner Handled in Breed is held immediately following regular judging of that breed in the same ring. The ring steward will excuse all exhibitors not eligible. The judge will then award Best Owner Handled in Breed.

Judging of the breed for the regular show may determine the dog that is awarded the Best Owner Handled in Breed.

Guidelines:

- If the Best of Breed winner of the regular show is eligible for Best Owner Handled in Breed it will also be awarded Best Owner Handled in Breed. In this case the dog will be eligible to compete in group competition for the regular show and group competition for Best Owner Handled in Group.
- If the regular show Best of Breed winner is not eligible for Best Owner Handled in Breed and the regular show Best of Opposite Sex is eligible, the regular show Best of Opposite Sex will compete against the eligible exhibits of the other sex to determine Best Owner Handled in Breed.
- If neither the Best of Breed nor the Best of Opposite Sex from the regular show is eligible for the Best Owner Handled in Breed and both the Select Dog and Select Bitch are eligible, the judge is to choose Best Owner Handled in Breed from the Selects and any eligible Winners Dog or Winners Bitch.
- If one of the Selects from the regular show is eligible for Best Owner Handled in Breed, excuse all eligible champions and then choose Best Owner Handled in Breed from the remaining eligible dogs of the opposite sex including the eligible Winners.
- If the regular show Best of Breed, Best of Opposite Sex, Select Dog and Select Bitch are not eligible, the judge may choose any eligible dog remaining in the ring including Winners Dog or Winners Bitch as the Best Owner Handled in Breed.

If no dog remaining in the ring is eligible for the Best Owner Handled in Breed competition, no award will be made and there will not be representation in group competition for the Best Owner Handled in Group.

Group and Best in Show Competition

- In the Group and Best in Show competition, the dog must be handled throughout the competition by an eligible owner.
- Group judging for the Best Owner Handled in Group may take place in separate rings from regular group judging.
- Judging for the Best Owner Handled in Show after regular Best in Show judging.

OBEDIENCE CLASSES:

Indoors - Ring Size 40' x 50' - Sunday Trials #1 am #2 pm)

No dog may be entered in both Novice "A" and Novice "B", Open "A" and Open "B" at the same trial. In determining class eligibility, if a dog shall have won a particular title before being entered or moved up, the handler shall have been notified by at least 2 different judges that the dog has won 3 qualifying scores for the required title. (However, a dog may continue to be exhibited for 60 days in a class after winning a particular title.)

Dogs fulfilling the requirements for a title may be moved to the next level of competition if the schedule permits. The transfer must be on the appropriate move-up form and submitted to the show secretary at least 15 minutes before the start of the class.

PRE-NOVICE - The Pre-Novice class is an elective class and earning the title is not a requirement to enter Novice classes. The Pre-Novice class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of PCD. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler must handle each dog in all 5 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercise. Only dogs that have not earned the title of CD may enter the Pre-Novice class.

NOVICE A - The Novice A class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of CD. Only one dog per handler is allowed in this class, and that person must handle the dog in all exercises. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. No person who has trained or exhibited a dog that earned a CDX title shall be allowed to handle a dog in this class.

NOVICE B - The Novice B class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of CD. Dogs in this class may be handled by the owner or any other person. The owner or any other person may handle a dog in this class. A person may enter more than one dog in this class. The same handler must handle each dog in all 6 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercises.

NOVICE C - The Novice C class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned the title CD or any higher obedience titles. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler must handle each dog in all 6 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercises. Dogs may compete in Novice C indefinitely. Scores earned by dogs in the Novice C class are not eligible for High In Trial and do not qualify a dog for any title. Dogs may be entered in the Novice C class in addition to any other official or unofficial classes for which they are eligible.

NOVICE INTERMEDIATE - The Novice Intermediate class is an elective class and earning this title is not a requirement to enter the Open classes. The Novice Intermediate class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned a CD or any higher obedience trial titles. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler must handle the dog in all 6 exercises. Dogs may compete in the Novice Intermediate class indefinitely. Scores earned by dogs competing in this class are not eligible for High in Trial. Dogs may be entered in the Novice Intermediate class in addition to any other official or unofficial classes for which they are eligible.

OPEN A - The Open A class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of CD but has not earned the title of CDX. The handler of any dog in this class must be the owner, co-owner or member of their immediate family. Only one dog per handler is allowed in this class, and that person must handle the dog in all exercises. Any person who exhibited a dog that has earned an OTCH title may not handle a dog in this class. When a dog is wrongfully entered in these classes, any scores awarded will be cancelled.

OPEN B - The Open B class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of CD. Dogs which have earned the title of CDX or any higher titles may enter in the Open B class. A dog may also be entered in the Utility Class in the same trial. Dogs in this class may be handled by the owner or any other person. A person may enter or handle more than one dog in this class. The same handler must handle each dog in all 7 exercises. Prior to the start of judging, the judge will choose which of the six numbered routines is to be performed. This choice will not be disclosed to the exhibitors until it is posted at ring side at least 30 minutes before the start of the class. In future assignments, judges are required to alternate the six routines so that each set will be used approximately the same number of times.

UTILITY A - The Utility A class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of CDX but has not earned the title of U.D. Any person who has trained or exhibited a dog that has earned a MOTCH title may not handle dogs in this class. The handler of any dog in this class must be the owner or member of their immediate families. Owners may enter more than one dog in this class. The same person must handle the dog in all exercises.

UTILITY B - The Utility B class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of CDX or UD. Dogs in this class may be handled by the owner or any other person. Owners may enter more than one dog in this class. The same person must handle the dog in all exercises. Prior to the start of judging, the judge will choose which of the six numbered routines will be performed. This choice will not be disclosed to exhibitors until it is posted at ring side at least 30 minutes before the start of the class. In future assignments, judges are required to alternate the six routines so that each will be used approximately the same number of times.

RALLY CLASSES:

(Indoors - Ring Size 40' x 50' - Friday AM #1, Friday PM #2, Saturday AM #3 and Sat PM #4)

No dog may be entered in both Advanced "A" and Advanced "B" at the same trial or Excellent "A" and Excellent "B" at the same trial.

RALLY NOVICE A - Dogs competing in this class may not have earned the RN title or any CKC obedience title other than PCD. No handler who has exhibited a dog through its CKC CDX title or CKC RA title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. A person may enter more than one (1) dog in this class. No dog may be entered in both Rally Novice A and Rally Novice B at any one (1) trial.

RALLY NOVICE B - Any dog may compete in this class until a qualifying score in the Rally Advanced class is earned. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged on leash, and all dogs must enter and leave the ring on leash.

RALLY INTERMEDIATE - This class shall be for dogs that have earned the R.N. title. A dog completing the R.I. or any other obedience or rally titles may continue to compete in this class indefinitely. The owner or any other person may handle dog in this class. A person may enter more than one dog in this class.

RALLY ADVANCED A - This class shall be for dogs that have earned the RN title but have not earned the RA title or any CKC obedience title other than PCD. No handler who has exhibited a dog through its CKC CDX title or CKC RE title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. A person may enter more than one (1) dog in this class. No dog may be entered in both Rally Advanced A and Rally Advanced B at any one (1) trial.

RALLY ADVANCED B - This class shall be for dogs that have won the Rally Novice (R.N.) title. A dog completing the Rally Advanced (R.A.) title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged off leash. All dogs must enter and leave the ring on leash.

RALLY EXCELLENT A - This class shall be for dogs that have won the Rally Advanced (R.A.) title, but have not won the Rally Excellent (R.E.) title or any CKC Novice Obedience title. No handler who has exhibited a dog through its CKC Companion Dog Excellent (C.D.X.) title or instructed dog training classes shall be eligible to enter this class. The handler of any dog in this case must be the owner, the co-owner, or a member of their immediate families. A person may enter more than one dog in this class, A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class .However, a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title.

RALLY EXCELLENT B - This class shall be for dogs that have won the Rally Advanced (R.A.) title. A dog completing the Rally Excellent (R.E.) title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class, A person may enter more than one dog in this class. All exercises are judged off leash except the Honor Exercise. All dogs must enter and leave the ring on leash.

RALLY MASTER - This class is for dogs that have earned the RE title. Any person may handle the dog in this class. Dogs must earn 3 qualifying scores of 85 points or more under at least 2 different judges.

GENERAL RULES GOVERNING THESE SHOWS

It is the responsibility of the Exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the Conformation Rule book are available online at www.ckc.ca

1. The Club reserves the right to remove any person from the show and/or show grounds designated for this event as deemed appropriate by the show committee. The Show Superintendent shall have full control of the above shows and trials, which will be governed by CKC rules.
2. Any dog excused by the Show Superintendent or the Show Veterinarian for any reason shall not, after being excused, compete in any class for any award for the balance of the show.
3. The show committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune, to either dogs, exhibitors or patrons.
4. A Judge or any person participating in any capacity at a Dog Show held under CKC Rules shall not be subjected to any indignity of any kind during the progress of the show and it shall be the duty and obligation of the Club holding the show to see that this rule is effectively carried out. The Show Superintendent shall promptly report to the CKC any infringement of the rules, and the Discipline Committee shall have the power to take such action as it deems fit on receipt of a report indicating that this rule has been violated.
5. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the show grounds.
6. **DOGS MUST BE READY FOR JUDGING.** The Club will not be responsible for and is not obligated to provide any service for notifying owners or agents of breed or class judging. No ring shall be held up waiting for exhibitors or handlers. Exhibitors & Handlers with more than one dog shall have substitute handlers available so the judging will not be delayed. All start times are **PACIFIC TIME.**
7. The owner of a dog entered in these shows is entirely responsible for any error in entering his/her dog, regardless of how or by whom the entry was made.
8. A dog once disqualified for any reason at a championship show held under these rules cannot again be shown at a show held under these rules until the dog has been examined by an official committee appointed by the CKC and the committee finds the dog is free from the condition which prompted the disqualification. Application for reinstatement must be accompanied by a fee of \$115 plus GST (for Canadian residents) (\$230 non-resident), which shall be forfeited to the CKC if the examining committee is satisfied that the dog should remain disqualified. All awards earned at a dog show in violation of this rule shall be canceled by the CKC and the owner of the dog is subject to disciplinary action.
9. Exhibitors and handlers will be responsible for their dogs and for their equipment left at the Show Grounds.
10. For the benefit of the health of animals and the pleasure of the exhibitors and spectators we insist upon keeping our grounds and buildings as clean as possible. Exhibitors are responsible for cleaning up after their dogs. Please exercise your dog **BEFORE** taking it to the Judging ring. Dogs are to be exercised in the designated areas only, not in the vicinity of the ring areas.
11. No entry fee will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, and Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club.
12. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of the Show Committee.

AGREEMENT

I (we) acknowledge that I (we), all exhibitors, handlers and patrons, know and abide by the "CKC Dog Show Rules", and that I am (we are) familiar with their content. I (we) agree that the Club holding this show has the right to refuse this entry for cause, which the Club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the Show and of the opportunity to have the dog judged and to win prize money, ribbons or trophies, I (we) agree to hold the Vernon & District Kennel Club, their members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of a dog while in or upon the show premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of a dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the Club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting thereof, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this show, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.

**CANADIAN KENNEL CLUB SCHEDULE OF
CHAMPIONSHIP POINTS**

SECTION 2. The schedule to be employed in the determination of the number of points to be allocated to a dog awarded WINNERS shall be as follows: (*Includes the dog awarded Winners.)

Dogs Competing*	1	2	3 to 5	6 to 9	10 to 12	13 or more
Points Allocated*	0	1	2	3	4	5

To determine the number of championship points earned by a dog awarded Winners, total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best of Opposite Sex and then consult the schedule set forth above. A dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for championship points. Further section 15.1.12 {C} has been added and states the dog must: "have earned at least one 2 point win either at the breed level or group level."

The system provides for additional points if a dog awarded winners also places in the Group as listed here under.

A class Dog awarded Best In Show at an all-breed championship show will be credited with five points inclusive of any points earned at the breed or group level. In no case may a dog earn more than five (5) points at a single show. To earn a Canadian Championship, a dog must earn at least ten championship points under at least three different judges; and be individually registered with the Canadian Kennel Club, or have a CKC Event Registration Number (ERN) and have earned at least one 2-point win either at the breed or group level.

In order to obtain a Grand Champion title, a dog must obtain a minimum of 20 points which must include a minimum of two wins of at least 2 points and at least two (2) points after 12 months of age. In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for Grand Champion points. (d) Only the highest points earned at a single show are carried forward.

15.2.4 Grand Champion Bronze (GChB) The title of Grand Champion Bronze may only be earned after the completion of the CKC conformation title Grand Champion is attained.

(a) Points for this title are only accumulated after the completion of the Grand Championship, and do not include the points earned in attaining the Grand Championship.

(b) To be awarded a Grand Champion Bronze title, a dog must attain a minimum of 50 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/Specialty level. Only the highest points earned at a single show are carried forward.

(c) Points accumulated prior to July 1, 2021 may be used to attain the GChB title, however, a minimum of five (5) points must be earned after July 1, 2021.

15.2.5 Grand Champion Silver (GChS) The title of Grand Champion Silver may only be earned after the completion of the CKC conformation title Grand Champion Bronze is attained.

(a) Points for this title are only accumulated after the completion of the Grand Champion Bronze is attained, and do not include the points earned in attaining the Grand Championship Bronze.

(b) To be awarded a Grand Champion Silver title, a dog must attain a minimum of 100 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/ Specialty level. Only the highest points earned at a single show are carried forward.

15.2.6 Grand Champion Gold: (GChG) The title of Grand Champion Gold may only be earned after the completion of the CKC conformation title Grand Champion Silver is attained.

(a) Points for this title are only accumulated after the completion of the Grand Champion Silver is attained, and do not include the points earned in attaining the Grand Championship Silver.

(b) To be awarded a Grand Champion Gold title, a dog must attain a minimum of 200 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best in Show/ Specialty level. Only the highest points earned at a single show are carried forward.

15.3 Grand Champion Excellent (GChEx) (48-06-12)

15.3.1 The title of Grand Champion Excellent may be granted only after the completion of the CKC Grand Championship Silver Title. Exhibitors will be required to submit to Shows & Trials the Grand Champion Excellent Record Sheet documenting the additional requirements. The Grand Champion Excellent Record Sheet Form is located on the CKC website.

15.3.2 To earn the title a dog must have earned the following during their career as a Special:

(a) one (1) Best in Show or a Best of Breed at a breed national specialty (where a minimum of 10 dogs have competed)

(b) three (3) Group 1st, or three (3) breed specialty best of breed wins.

(c) a CKC performance title from any CKC Event. Titles excluded are: CGN, Herding Novice Tested Certificate, all Instinct titles from all events, as well as all Sprinter titles and all Chase Ability Program titles.

15.3.3 Best in Show, Best of Breed at a National Specialty, 3 Group wins, or 3 Specialty Best of Breed wins, must be attained after the completion of a regular championship. The performance title may be attained at any time in the dog's career.

1. Exhibitors are required to complete the Grand Champion Excellent Record Sheet form located on the CKC website and forward to CKC upon completion of requirements above.

2. Grandfathering of the previous version of the Grand Champion Excellent title will be honoured up until July 1, 2022.
